### 5. Old Business

- a. Fall Apparel Sale lessons learned.

  - ii. Possible changes: hat sizing more clear for kid vs. adult. Email out pickup information instead of relying solely on Facebook. For sorting items, find better process for identifying items by their item number. Have a "double check table".
- b. Sweet Treat Day lessons learned
  - i. Positives: fresh/gourmet bakery items & individual/handheld treats went over well. Drinks were good diet coke, seltzers, hot cocoa k-cups. 3 locations was good for teachers.
  - ii. Possible changes: need to-go containers or more individual wrapped items. Have fruit as an alternative for low-sugar items. Need to set up the night before, and then drop food off in the morning.
